**JOINT RESOLUTION BETWEEN THE BOARD OF COMMISSIONERS  
OF THE COUNTY OF ELKHART, INDIANA AND THE COUNTY OF  
KOSCIUSKO, INDIANA**

WHEREAS Indiana Code § 36-1-11-8 permits the transfer or exchange of property between governmental entities upon terms and conditions agreed upon by the entities as evidenced by the adoption of a substantially identical resolution by each entity;

WHEREAS the Board of Commissioners of the County of Elkhart, Indiana is the County executive and legislative body and is by law authorized to adopt ordinances and resolutions for the administration of Elkhart County Government;

WHEREAS the Board of Commissioners of the County of Kosciusko, Indiana is the executive and legislative body and is by law authorized to adopt ordinances and resolutions for the administration of the Kosciusko County Government;

WHEREAS the Board of Commissioners of the County of Kosciusko, Indiana, and the Board of Commissioners of the County of Elkhart, Indiana, are jointly adopting this resolution to satisfy the requirements of Indiana Code § 36-1-11-8;

WHEREAS the Board of Commissioners of the County of Elkhart, Indiana, desires to transfer and give the dog Corsa, which is used in Elkhart County for police functions;

WHEREAS the Board of Commissioners of the County of Kosciusko, Indiana, desires to accept the transfer and gift of Corsa for and on behalf of the Kosciusko County Sheriff;

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of the County of Elkhart, Indiana hereby transfers and gives to the Board of Commissioners of the County of Kosciusko the dog Corsa in "AS IS" condition for the use and benefit of the Kosciusko County Sheriff, with such transfer to be made on or about the 4<sup>th</sup> day of March, 2024;

BE IT FURTHER RESOLVED that the Board of Commissioners of the County of Elkhart, Indiana, and the Board of Commissioners of the County of Kosciusko, are hereby authorized to execute the necessary transfer papers to effectuate and carry out the intent of this Resolution;


NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Kosciusko County, hereby accepts the transfer and gift of Corsa in "AS IS" condition from the Board of Commissioners of the County of Elkhart, Indiana for the use and benefit of the Kosciusko County Sheriff effective on the date such transfer is made.


BE IT FURTHER RESOLVED by the Board of Commissioners of Kosciusko County, that, in consideration of the transfer and gift of Corsa, the Board of Commissioners of Kosciusko County, releases, acquits, and forever discharges the Board of Commissioners of the County of Elkhart, Indiana and its elected officials, representatives, successors, insurers, agents, assigns, and employees, from any and all losses, costs, damages, dues, debts, claims, interest, demands, claims for attorney fees, liens, subrogations, actions or causes of action, at law or in equity, known as well as unknown, past, present and future, arising from the Kosciusko County Sheriff's ownership, use, operation, or possession of Corsa.
