**INTRO**

Riverboat Revenue Sharing IC 4-33-13-5(d) requires a distribution of Except as provided in subsections (k) and (l), before August 15 of each year, the state comptroller shall distribute the wagering taxes set aside for revenue sharing under subsection (a)(1) to the county treasurer of each county that does not have a riverboat according to the ratio that the county's population bears to the total population of the counties that do not have a riverboat.

Below are the FY 2026 calculations of the annual amounts for each recipient, along with a breakdown by county, city, and town of the monthly distribution amount. Section 1 represents the total amount that will be distributed to the County Auditor. Section 2 is the allocation for all recipients within the county based on the population.
