Definitions:

Venue: A Place Where Events of a Specific Type Are Held, Including Weddings, Ceremonies, And Similar Gatherings. This Definition Does Not Include Mass Gathering Events as Defined by The Indiana State Board of Health.

Excavation Business: - Location Of Excavation Use Office/S And Site of Storage or Materials and Equipment. This Does Not Include Activities Occurring Onsite Such as Mineral Extraction or Mining.

Said amendment, revision, and addition to the Kosciusko County Zoning Ordinance shall, if adopted, apply to those unincorporated areas of Kosciusko County as well as those participating municipalities within the County including the Town of Syracuse, Town of Milford, Town of North Webster, Town of Etna Green, Town of Pierceton, Town of Burket, Town of Claypool, Town of Leesburg, and the Town of Silver Lake.
