

ORDINANCE NO. 2015-08-13-001

ORDINANCE GRANTING THE RECORDER'S REQUEST TO USE MONIES FROM THE RECORDER'S  
RECORDS PERPETUATION FUND TO SUPPLEMENT THE RECORDER'S 2016 BUDGET

By the affidavit contemplated by I.C. 36-2-7-10.2(b), the County Recorder has requested the sum of \$5,000.00 of the Recorder's Perpetuation Fund be used to supplement payment of the expenses of her office for the 2016 calendar year.

Pursuant to I.C. 36-2-7-10.2(c), upon receiving the Recorder's affidavit, the County Council may adopt an ordinance approving the Recorder's request.

The Recorder's affidavit is in proper form and content and the County Council wishes to grant the Recorder's request.

NOW, THEREFORE, IT IS ORDAINED AS FOLLOWS:

The request of the County Recorder asking that the sum of \$5,000.00 of the Recorder's Perpetuation Fund be used to supplement payment of the expenses of her office for the 2016 calendar year is granted.

AFFIDAVIT

I, Joetta L. Mitchell, after first being duly sworn upon my oath, state as follows:

1. I am the duly elected Recorder of Kosciusko County, Indiana.
2. The Recorder's Perpetuation Fund (RPF) is an unappropriated fund for the purpose of preservation of records, and is in the control of the County Recorder.
3. The current revenue to the RPF is sufficient to fulfill the statutory purpose of the fund.
4. The technology of the county recorder's office is presently updated and at a level to sufficiently meet the statutory purposes of the fund and the county recorder's office.
5. The RPF has a sufficient reserve, consistent with the recorder's plan, to capitalize the next technology or other records management upgrade necessary to fulfill the statutory purpose of the fund and the county recorder's office.
6. I am specifically requesting the sum of \$5,000 of the RPF be used to supplement the payment of the expenses of the county recorder's office for 2016.
7. The requested amount will cover the chief deputy's salary and benefits, service contracts, and travel and education expenses for the required recorder training, not covered by the Elected Officials' Training Fund.

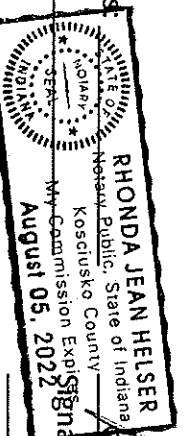
