WHEREAS, the Kosciusko County Council is the designating body approving abatements established under IC 6-1.1-12.1

WHEREAS, IC 6-1.1-12.1-17 applies to a statement of benefits approved after July 1, 2013. The designating body shall establish an abatement schedule for each deduction allowed under this chapter. An abatement schedule must specify the percentage amount of the deduction for each year of the deduction. An abatement schedule may not exceed ten (10) years.

BE IT THEREFORE RESOLVED, the Kosciusko County Council wishes to apply the below schedule to all abatements unless otherwise stated.
