ORDINANCE NUMBER 12-7-31-002 ✓

BE IT ORDAINED by the Board of Commissioners of Kosciusko County, State of Indiana:

Section 1.

WHEREAS, Margot Brown Pahud has filed her Petition for vacation of portions of an unnamed public road in the plat of Lake View Park, with the Board of Commissioners of Kosciusko County, Indiana; and

WHEREAS, a hearing on said Petition was set for July 31, 2012 at 9:15 a.m. and notice of said hearing was published in the *Warsaw Times Union* and The *Milford Mail-Journal* as required by law; and

WHEREAS, the Kosciusko County Area Plan Commission has recommended vacation of the public ways; and

WHEREAS, the time of said hearing has arrived and a hearing is conducted thereon; and

WHEREAS, the portion of unnamed road sought to be vacated does not serve as access to any property, does not serve as access to any public place, and vacation will not hinder the orderly development of the area. The portion of the public way to be vacated is described as follows, to-wit:

All that portion of the unnamed public road lying north of and adjacent to Lots 12 & 13 in Lake View Park from the west line of Lot 13 extended north, to the east line of Lot 12 extended north

WHEREAS, the Board of Commissioners of Kosciusko County, Indiana, has jurisdiction to vacate the public ways described in said Petition.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Kosciusko County, Indiana that the portions of the public way herein described are now vacated.

Section 2.

That this Ordinance shall be in full force and effect from and after its passage.
