WHEREAS, Prairie Township ("Township") holds fee simple title to 121 E. Main Street:

WHEREAS, the improvements located on 121 E. Main Street need to be demolished ("Improvements");

WHEREAS, the County will fund the demolition expenses for the Improvements;

Main Street from the Township to the County in consideration of the County funding the demolition of the Improvements and for no monetary consideration; and

WHEREAS, the Trustee believes that it is in the best interest of the Township and in the best interest of the community as a whole to transfer fee simple title to 121 E. Main Street to the County in consideration for the County funding the demolition of the Improvements and for no monetary consideration.
